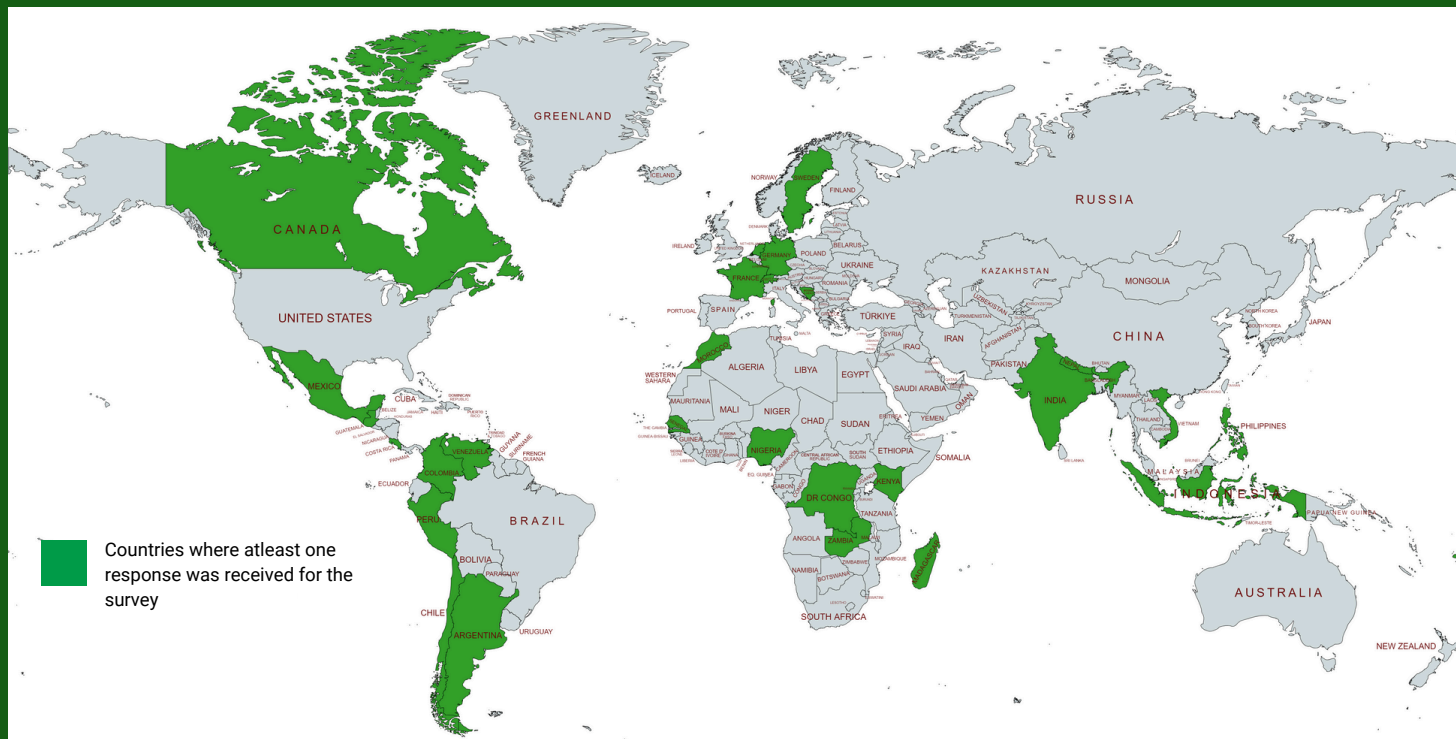


# Participation of Civil Society and Rightsholders in NBSAPs Consultations



## About the Survey\*

The Human Rights & Biodiversity Working Group is a platform of civil society organizations, rights holders networks and constituencies, UN agencies and others working together in the Convention on Biological Diversity space to advance human rights based approach (HRBA) advocacy and implementation of the Kunming Montreal Global Biodiversity Framework (KM GBF).

In line with the strong call in the KM GBF for a whole-of-society approach and importance of a "full, effective, inclusive, equitable and gender responsive participation" (Target 22) the Working Group has developed the following questionnaire to assess the level of participation of civil society and rights holders in the National Biodiversity Strategic and Action Plan (NBSAP) process.

Philippines providing 8 of those responses

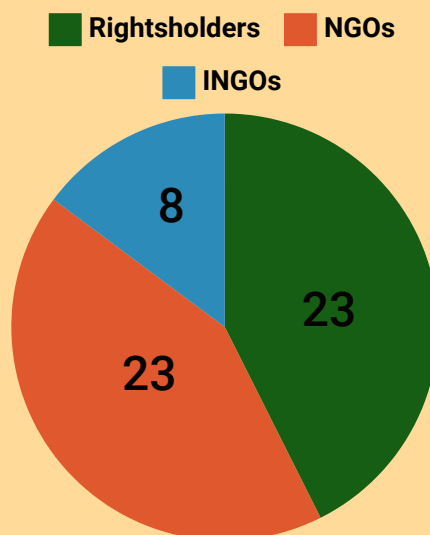


Fig 1. Civil Society Organisations which provided responses

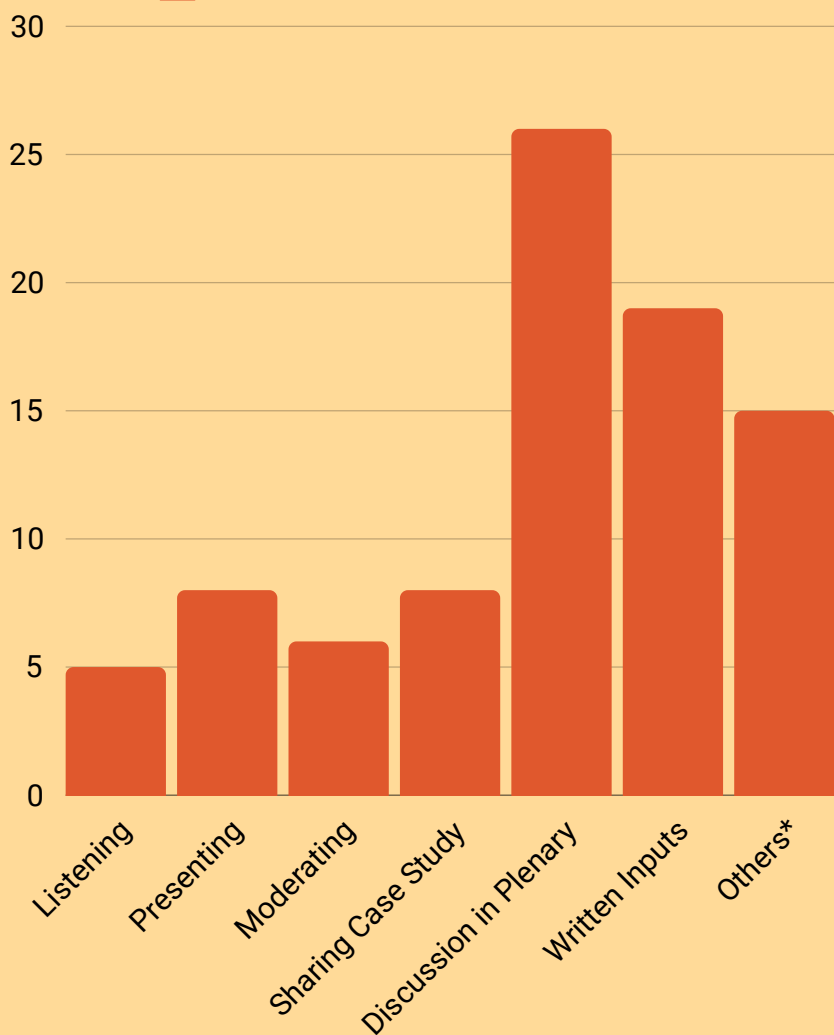
